

# 2022-2023 WVSD Student Technology Acceptable Use Policy (AUP)

***Before access to the computer network is allowed, the following document must be read carefully, discussed thoughtfully, and signed by you and your parent or legal guardian. Violations may result in loss of access, as well as other disciplinary or legal actions.***

Wishkah Valley School District is pleased to offer access to the school network and the internet to students for educational use. With this privilege come responsibilities requiring respectful, responsible, efficient, ethical and legal utilization of network resources. If a user violates any of these provisions and related district policies his or her access privilege will be terminated. This agreement will define the educational objectives and guidelines for use, as well as unacceptable uses which will lead to revocation of access and possible disciplinary and/or legal action. Please see board policy 2022/2022P for a detailed list of acceptable and unacceptable uses.

## TERMS AND CONDITIONS

1. **Acceptable Use** - Access must be in support of education, research, and consistent with the educational objectives and policies of the District.
2. **Unacceptable Use** - Unacceptable use may include but not limited to music and video downloads, violations of copyright law, use of or creation of threatening/obscene material, cyberbullying, sharing of passwords, plagiarism, bringing software and music from home, distributing material protected by trade secret, use for commercial activities, political or campaign lobbying or information, illegal activities, tampering with, or vandalism of, programs, data, computers, or the system.

***THE ADMINISTRATION WILL DETERMINE WHAT IS UNACCEPTABLE USE, AND THEIR DECISION IS FINAL.***

3. **Internet Access and Email Usage** – Internet access and email usage is monitored and is not to be considered private. Network administrators may review files and communications to maintain system integrity and ensure that users are observing the terms and conditions of this contract in the spirit of responsible, respectful, efficient, ethical, and legal utilization of network resources for research and educational purposes, as is intended. All email correspondence, incoming and outgoing, is to be considered the property of Wishkah Valley School District. Student email use at school is restricted to wishkah.org email accounts.

## Acceptable Use Policy Student Agreement:
