WISHKAH VALLEY SCHOOL DISTRICT 2019-2020 REDUCED EDUCATIONAL PROGRAM RESOLUTION NO. 2019-04-11-15

WHEREAS, the Board of Directors has reviewed the report of the Superintendent concerning anticipated student enrollment, estimated revenue and expenditures for the 2019-2020 fiscal year, the seniority list for certificated instructional staff, and the current number of anticipated and confirmed resignations, discharges, nonrenewals, leaves and other anticipated vacancies in certificated staff positions;

WHEREAS, at the present time the level of funding the District will receive from certain federal, state, and local funding sources is uncertain, but it currently appears that the District will have a loss of financial revenues that will not allow to maintain the current educational program and services and number of certificated employees for 2019-2020;

WHEREAS, even if additional funding in excess of current projections becomes available, the

Board of Directors desires to exercise its discretion to allocate funds under applicable law and consistent with negotiated agreements in the best interest of the District; and

WHEREAS, the Board of Directors has considered these recommendations of the Superintendent, and has further considered the financial resources of the District and its student needs and educational goals, and it has determined that for 2019-2020 a decrease in state and other funding, declining student enrollment, and other circumstance that have created a financial emergency that require the number of certificated employees to be reduced through adoption of a reduced educational program for the 2019-20 school year;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Wishkah Valley School District as follows; the Resolution No. 2019-04-11-15, adopted 05-02-2019 is hereby revised to state:

I.

Certificated Instructional Staff Program Reductions

The current 2018-19 educational program will be reduced for the 2019-20 school year by 2.79 FTE certificated instructional positions as follows: (FTE cuts by contract categories per Article XII, Section 3 B) Elementary K-6: 2.29 FTE; Secondary 7-12: CTE (Shop) .5 FTE.

II.

The Superintendent is directed to take such action as may be required by law and the negotiated

agreement to give appropriate and timely notices of nonrenewal to certificated employees and their

bargaining representatives to implement the above-described reduction of the educational program and

certificated staff, and to provide timely notice to layoff, reduce, reassign, and transfer certificated staff

members as required under the applicable bargaining agreement and law.
